HELPFUL HINTS FOR TENANTS AND GUARANTORS

Application forms must be completed in BLOCK CAPITALS and using Black ink

Address for past 3 years with full postcode is essential

All employment for the past 3 years must be included when completing the application. Use separate sheet if necessary.

Telephone numbers, Fax numbers and or email address of your line manager or personnel dept must be included in your application form, this will help with a speedy response.

Please inform your employment contact that we will be getting in touch for confirmation of employment.

For self employed tenants, you must either submit the last 3 years accounts or include a contact name, phone, fax or email address of your accountant.

Retired tenants must provide proof of pension with application.

A tenant must have an income of the rent multiplied by 30 (EG: Rent being £400 x's 30 = income of £12,000)

GUARANTORS as above but must be a home owner and resident in the UK

All of the above points apply except the income level is calculated by multiplying the rent by 3 then multiply by 12 (EG: Rent being £400 x's 3 = £1200 then x's 12 = £14,400)
